AN ORDINANCE DECLARING A SQUAD CAR SURPLUS PROPERTY AND AUTHORIZING SALE OF THE SAME

PREAMBLE

WHEREAS, the City of Tuscola, Illinois (hereinafter the "City") is a duly established and functioning home rule municipality in Douglas County, Illinois; and

WHEREAS, the City owns and possesses a certain 2016 Chevrolet Impala Police Sedan with Vehicle Identification Number 2G1WD5E36G1133562, (hereinafter the "Squad Car,"); and

WHEREAS, said Squad Car is no longer necessary or useful to the City or in the best interest of the City to retain ownership thereof; and

WHEREAS, the City does hereby desire to declare the Squad Car surplus property and to dispose of the same pursuant to ordinance authorizing the same.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TUSCOLA, DOUGLAS COUNTY, ILLINOIS, THAT:

Section 1. The aforementioned Squad Car is hereby declared surplus property.

Section 2. The City Administrator is hereby authorized and directed to sell the Squad Car at the best available price and by the most advantageous or convenient method, in his sole discretion, including but not limited to salvage, and to execute any and all documents necessary for the conveyance of ownership of the Squad Car to the Buyer or Buyers.

Section 3. Severability. Should any part of this Ordinance be declared invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Ordinance.

Section 4. Effective Date. This ordinance shall be effective upon its passage, approval, and publication as required by law.
