**PREAMBLE**

WHEREAS, the City of Tuscola (hereinafter the "City") is a duly established home-rule municipal corporation of Douglas County, Illinois; and

WHEREAS, the City has the power and authority to regulate the stopping, standing and parking of vehicles upon publicly owned property pursuant to 625 ILCS 5/11-208; and

WHEREAS, the City has previously promulgated ordinances, collectively contained in Chapter 76 of the City of Tuscola Code of Ordinances, regulating the parking of vehicles within the City, and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF TUSCOLA, ILLINOIS AS FOLLOWS:

ARTICLE ONE. Adoption of Recitals.

The foregoing recitals are incorporated in this Section by reference.

ARTICLE TWO. Amendment of Schedule I: Parking Prohibited at All Times.

Chapter 76, Schedule I "Parking Prohibited At All Times" is hereby amended by the addition of the following entry:

<u>Street</u>	<u>Between</u>	<u>Side</u>
Justice Street	North Line Rd. and Barker St.	West

ARTICLE THREE. Severability.

Should any part of this Ordinance be declared invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Ordinance.

ARTICLE FOUR. Repealer.

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed insofar as they are in conflict with this ordinance. Except as detailed above, all other Ordinances of the City of Tuscola shall retain their current language and remain in full force and effect.

ARTICLE FIVE. Effective Date.

The City Clerk shall cause notice to be published in a newspaper of general circulation within the County that this Ordinance has been adopted and that copies are available upon request to the City Clerk. In addition, copies of the ordinance shall be posted in the City Hall and the Community Building. The publication shall be made within fifteen (15) days of the adoption of this Ordinance. The Ordinance shall be in full force and in effect twenty five (25) days after said date of publication.
