## Tourism Board Meeting Tuscola City Hall – 214 N Main ST June 15, 2021

The meeting was called to order at 8:30 am. In attendance: Drew Hoel, Bill Hill, Michelle Black, Anna Nelson, and Alta Long.

A quorum was not present. The bills list and minutes were tabled till next meeting.

## **Old Business:**

Anna updated the board on the fireworks display. The contract was approved by the city council at last night meeting for July 10<sup>th</sup>. She explained due to unknown restrictions a festival was not able to be planned this year. There will be several activities happening during the week including VFW parade, pancake breakfast, and virtual 5K. As well as possible outdoor movie, soccer 3 on 3 tournament. Anna will put together a list of activities later this week. The board discussed possibly allowing food vendors during fireworks.

Anna gave a brief update of upcoming event. The Miss Tuscola Pageant is planned for July 30-31. They are still deciding how they plan to break up the different pageants, it will depend on how many participants they get in each division. Anna will be sending out donation request for them again this year.

Anna informed the board on the summer billboard project. Billboards have been secured and the vinyl is being printed. They did have to choose different billboards than the original ones from the proposal due to high demand, which saved \$2,000. However, the billboards we own are in worst conditional than originally anticipated. So an additional \$1,700 is needed for repairs. It also unlikely the billboards will be fixed before summer because they are unable to access the road to the billboard until after farming season.

The board briefly discussed Amish Country of Illinois and the partnership with the other communities. Alta explained the group has not received the state tourism grant for several years and since that happened several communities have lost interest. She asked the board to consider focusing efforts with Visit Champaign or continuing to do both Visit Champaign and Amish Country.

Anna noted weekly posts on the ACOI social media with Ingrid have been doing very well. She added the Jarman is now offering Bed and Breakfast suites and meeting rooms.
