Anna presented a downtown marketing idea. John McDevitt, from the Vault, proposed an idea he developed with a group of artists. Their idea is to brand the downtown as the Railway Arts District. They are still developing the overall idea but it would define the area from the main and 36 to Sale Street. The group thought the concept would set them apart from other art districts. They would like to develop a logo, do group advertising, as well as corridor signage.

Overall the board was not sold on the Railway idea, they did however like the idea of calling it an arts district. Drew mentioned he thinks the board would be interested in funding the initiatives, not necessarily a logo. Overall the board agreed some collaborative marketing would be great for the downtown. Anna said she would work with John to get a proposal from him

Drew made a motion to adjourn and was seconded by Donna. All in favor motion passed.
