Drew mentioned to contact Dave Butler to see what type of timing system he used in the past. Overall the board agreed that \$600 was very expensive to receive poor service. The parade was short, which is typical for the christmastown parade. However many people lined the street downtown to watch. Becky's Buddies had over 40 vendors and they had good attendance both days.

New Business:

Anna presented to the board an opportunity to contribute to the IHSA State Tournament bid, to bring the boys basketball state tournament back to Champaign. Visit Champaign, Champaign tourism department, has organized the bid. Anna stated that the main benefit she expects for Tuscola from this event would be hotel guest staying in Tuscola for inexpensive hotel rates and room availability as well as shoppers to Tanger. The board discussed various amounts they would like to contribute. The boards agreed upon a \$2,000 annual contribution. Drew said he would like to know what type of promotion the board would receive for making a contribution. Anna said she would follow up with the Champaign tourism director. Randy made a motion to tentatively approve a \$2,000 annual contribution for 5 years pending what type of promotion Tuscola will receive. Phyllis seconded that motion.
