## Tourism Board Meeting May 20, 2014

The meeting was called the meeting to order approximately 8:30 am. In attendance: Donna Kidwell, Drew Hoel, Devon Flesor, Karen Dukeman, Alta Long and Anna Marx.

Motion to approve the minutes from the April 15,2014 Board meeting made by Donna, seconded by Karen. All in favor, motion passed.

Motion to approve the bills list from 04/11/14 - 05/16/14, in the amount of \$1,103.45 made by Devon, seconded by Karen. All in favor, motion passed.

## Old Business:

Alta and Anna gave the board an update on the Sparks in the Park. Danny Matthews has booked 2 bands for the evening entertainment, the Crossman Bands and Albert Flasher. Alta is trying to work something out with the museum to make it a fundraiser for them. Forms for 3 on 3 will be dropped off at the schools. Also variety show forms and parade entries have been mailed out to churches. Miss Tuscola, Jr Miss and Little Miss will be conducting a donation letter writing campaign for fireworks. The letter has been written, and will be mailed very soon.

Anna gave an update for the Market on Main. The pushcart for the sponsors to take to the corner is in the works. Bill Hill hopes to have it completed by the first market. So far there are 7 vendors signed up for the entire season. So far there has been no one signed up as a resale vendor. Anna has placed ads in the Tuscola Journal as well as social media posts.

Anna informed the board on a successful Tuscola Train Day. Fred thought that there was a total of 300 people through out the day and 12 vendors set up. The horn exhibit vendor said he had 20 times more people at their booth than when they set up in Monticello. Devon mentioned she saw some business from the Train Day. Anna said she got the impression from Fred that he would be willing to help out with the event next year, but would not want to be the sole organizer of the event.

Anna explained to the board that the Arts Festival has been postponed to next summer or early fall. They had a difficult time finding a date that the community building was free this year, which would be the rain plan. This will allow more time to plan and to advertise the event. The arts council is also interested in decorating the concrete planters on the corners downtown. They hope to develop a few designs to present to the board for approval.

## New Business:

A grant application was submitted by The Vault Arts Collective for the Tourist Directional Signage in the amount of \$240. A motion to approve was made by Drew and seconded by Karen.

A grant application was submitted by The Vault Arts Collective for their 1<sup>st</sup> Saturday event entertainment. The grant requested would be for \$3,600 for the entire year, an average for \$300 per month. A motion to approve was made by Devon and seconded by Drew. All in favor, motion passed.

A grant application was submitted for the High Heel Dash. They requested \$600 to be used to purchase a banner. In order to not have a tax form sent to the individuals, the board suggested the amount only be approved up to \$575. A motion to approve was made by Devon and seconded by Karen. All in favor, motion passed.

Alta presented to the board a grant application that was not included on the agenda. The grant application was submitted by Danny Matthews for a musicians swap meet to be held at the Douglas County Museum. He asked for \$100 for 10 commercials to be played on WKIO. A motion to approve the grant was made by Drew and seconded by Donna. All in favor, motion passed.

Anna presented to the board a yearlong radio contract with WPGU. This contract would be for shopping commercials for Tanger and downtown on busy weekends on campus. Anna explained that by committing to the entire year they offer a 50% discount on their rates. Devon made a motion to approve the contract and Donna seconded it. All in favor, motion passed.

Anna present the Illini Radio summer plan. In order to get this discount you must sign up for 3 consecutive weeks. These commercials include High Heel Dash, Sparks in the Park, and the Car Show. Karen mentioned she really likes working with the Illini Radio Group and has had good results working with them. A motion to approve the grant was made by Karen and seconded by Donna. All in favor motion passed.

Donna made a motion to adjourn, seconded by Devon. All in favor, meeting adjourned.
