Tourism Board Meeting November 21, 2017

The meeting was called to order approximately 8:30 am. In attendance: Drew Hoel, Morrie Mendenhall, Ashley Swinford, Donna Kidwell, Alta Long, and Anna Nelson.

Motion to approve the minutes from the October 17, 2017 board meeting made by Donna, seconded by Ashely. All in favor, motion passed.

Motion to approve the bills list from 10/13/17-11/17/17 in the amount of \$11,840.01 made by Donna, seconded by Ashley. All in favor, motion passed.

Old Business:

Anna reminded the board that Christmastown is coming up. She said Becky's Buddies will be hosting the vendor fair again. Amber Seip will organize the 5K again, and the museum will have breakfast with Santa. Anna explained she very excited about the carriage rides downtown on December 1. They plan to have 2 carriages to help with the wait time. Several businesses will be open late, pictures with Santa, and activities for kids.

Anna explained she submitted the order to have the new logo decals installed on the doors, but it's been too cold to have them installed. They hope to have a warmer day where he can install them.

Alta showed the 2 new WCIA commercials that started running last week. Anna explained they decided to do 2 commercials to fit in as many businesses as possible. Once holiday shopping is over they will put together a new commercial that is more general Tuscola, not just holiday shopping. Anna also showed the board the geo fencing ads that have started running. These ads are targeted at Market Place Mall, Cross County Mall, and Hickory Point.

The downtown trick or treat and library Halloween party was a huge success! Devin Black had people sign in as they arrived at the party and he had 667 people attend in just two hours. Many downtown businesses ran out of candy and had to go get more.

New Business:

Anna presented a grant request for the Rural Life Antique Show. The grant request is for advertising done for the November 2017 show. Ads were placed in Maine Digest and Simple Living Magazine, both national publications. Donna explained that the show is growing and they've added a third location at Forty Martyrs Hall. She also said attendance of the show was over 1,000 people. Morrie made a motion to approve the \$1,500 grant and Ashley seconded. All in favor motion passed.

Anna presented a grant request from Flesor's Candy Kitchen for their interstate signage. Anna explained this is an annual fee of \$660 and is for the signs located on the interstate off ramp. Donna made a motion to approve the grant and Morrie seconded. All in favor motion passed.

Anna presented a grant request from the Vault Arts Collective. The grant is for various advertising including WCIA television commercials, printing of brochures, and signage. Anna explained the commercials started last week and will run for one month. The signage request is vinyl decals that were added to the front windows. Anna thought this might not qualify for a tourism grant. Drew agreed and said they haven't funded projects like this in the past. Drew made a motion to approve \$2,000 grant for the advertising and brochure printing. Donna seconded. All in favor motion passed.

A motion to adjourn was made by Drew and seconded by Donna. All in favor motion passed.
