Tourism Board Meeting March 20, 2018

The meeting was called to order approximately 8:30 am. In attendance: Donna Kidwell, Drew Hoel, Ashley Swinford, Allen Schwass, Alta Long, and Anna Nelson. Also in attendance were Odd Fellow Lodge members.

Motion to approve the minutes from February 20, 2018 board meeting was made by Donna, seconded by Ashley. All in favor motion passed.

A motion to approve the bills list from 2/16/18-3/16/18 in the amount of \$3,190.09 made by Donna, seconded by Ashley. All in favor motion passed.

Old Business:

Anna updated the board on the Miss Tuscola Pageant. The pageant will be this Saturday at the high school. Anna said they have had many local businesses contribute items and financial donations.

Alta updated the board on the history map. She explain that the map has now been added to our website and now it's just a matter of finding and adding information. Anna said she has been in communication with Anna at the museum and the board has requested a \$1,000 grant in exchange for their contribution of information. The board was in favor of this amount to be given to the museum.

Anna updated the board on Sparks in the Park. She said she working on the Cola Wars tournament. She has contact Andy Romine to have the football team involved with current students or possibly alumni. She hasn't heard back. Hopefully she will have more of an update next week. Anna also explained that the high school basketball team will not be able to sponsor the 3 on 3 tournament this year. She has contacted Biddy Basketball and they seem interested. They will let her know if they can find the volunteers to help out. Battlecreek band will be playing in the evening before the fireworks. She has also reserved a stage for the evening and band will bring stage and lighting needed.

The board discussed the WEIU- Our Story project. Anna updated the board that Sarah Busch Lincoln, Tuscola First Federal, and Edward Jones have committed to sponsorships. Ameren and Christie Clinic are also interested, but have not committed. The board discussed how much they would like to fund the project. They wanted to contribute, but do not want to paying for the entire project. Donna made a motion to approve a \$2,000 sponsorship level and Allen seconded. All in favor motion passed.

Members of the Odd Fellow Lodge were present at the meeting to answer questions about their grant request. They have requested a \$5,000 grant for their upcoming Odd Market. The grant request would include funds for stage, porta potties, and advertising. The group explained that the attendance was over 550 at their last event. They hope expanding the music will bring more attendees. They believe this will be a family friendly atmosphere. They do plan to have a craft beer tent at the event. After much discussion the board decided to partially fund the grant for \$3,000. The grant can be used for any of the qualifying tourism items. Drew made a motion to approve the \$3,000 grant request and Ashley seconded. All in favor motion passed.

New Business:

Alta presented the FY19 budget to the board. The budget included various community events like Sparks in the Park, Outdoor movies, Christmastown, and Miss Tuscola. As well as new vinyl for billboards and the history map project. Ashley made a motion to approve the budget and was seconded by Donna. All in favor motion passed.

Anna presented the Outdoor movie night and Artisan market. She has begun planning the events for this summer. They plan to have them the 3rd Friday night of May, June, July and August. She will start promoting and getting vendors signed up.

WCIA has chosen Tuscola as one of their live "Our Town" segment locations on August 17. They will be broadcasting live all day with the live show starting at 4pm. Anna said she is working with WCIA to help with content for the live show. She will keep the board updated on this project as it develops.
