### Resolutions

Administrator Hoel called council's attention to a resolution stating we will comply with the requirements of the IDNR OSLAD grant application and provide matching support, if awarded. The overall scope of the project has changed from tennis and basketball court resurfacing to now include replacement of some of the lights on the baseball/softball diamonds at Ervin Park. Hoel went on to say if we resurfaced the courts and replaced all the lights on the four diamonds, the scope of the project could be as much as \$800,000. Hoel added he believes the resurfacing and light replacement on three of the diamonds is more realistic and would cost somewhere in the area of \$650,000. The grant is a 50% grant with a maximum of \$400,000. Hoel noted if the grant is awarded, we would still be spending a lot of money on capital improvement but anytime you can get a 50% grant, those are good terms. Day moved to approve resolution 2018-R-4, a resolution to authorize the submission of the Illinois Department of Resources OSLAD grant application for tennis and basketball court resurfacing and replacement of lights on the ball diamonds at Ervin Park. Shoemaker seconded. VOTE YEA\* Cleland, Day, Rund, Shoemaker, Slaughter, Truitt, Waldrop.

- Hoel stated he spoke with Mayor Kleiss about the appointment of a police department
  Administrative Assistant and would like to present the name of Pennie Trinpler as the
  candidate for the position. Hoel added Joyce Ragle, long time Administrative Assistant,
  has been filling in for the department part time since her retirement several years ago.
  Ragle is ready to be completely retired, Hoel added. Truitt moved to approve the
  appointment of Pennie Trinpler as full time police department Administrative Assistant @
  \$15.85 per hour. Slaughter seconded. VOTE YEA\* Cleland, Day, Rund, Shoemaker,
  Slaughter, Truitt, Waldrop.
- Hoel presented the name of Jud Wienke as a part time police office for the Tuscola department. Chief Hastings added we have lost two part timers from the department in the past few weeks. Day moved to approve the appointment of Jud Wienke as a part time police officer @ the published part time rate of \$16.50 per hour. Rund seconded.
