Anna reminded the board they approved a \$200 ad in the budget for this event when they passed the yearly budget.

Christmastown is just a couple months away. This year's event will be from Nov 30 – Dec 2. She explained they reserved the carriage rides again for Friday night. Anna hopes to get downtown businesses involved that evening. Becky's Buddies are planning to do the vendor fair again as well.

Anna said the harvest sign will be going up in the next few weeks. She is working on sourcing pumpkins for the display. They hope to have the downtown decorated once the weather cools off.

Anna said they library will once again be hosting the downtown Trick or Treat on October 29 from 5:30 to 7:30.
