Shoemaker seconded. Administrator Hoel pointed out the pay request from Owen Tucker anticipated Tucker would get some work done on Friday afternoon. Resolutions

Administrator Hoel presented a resolution regarding the city's drug and alcohol policy and testing. Hoel added this resolution is necessary to change our consortium membership and continue with on site testing. Cleland moved to approve resolution 2013-R-6, a resolution adopting a revised drug and alcohol policy and authorizing membership in the Midwest Truckers Association, Inc. Requests for TIF Assistance

Administrator Hoel discussed the final redevelopment agreement between Tuscola Properties LLC, and Tuscola Investments, LLC. This agreement is for the property at 1000 East South line Road, site of the planned Lambo's Travel Center. Hoel added the agreement is essentially the same as the agreement approved in September which states the City will provide \$1.7 million in infrastructure at the site. This remains the same. Hoel also added Attorney Bequette has signed off on the redevelopment agreement. Shoemaker moved to approve the redevelopment agreement between Tuscola Properties, LLC, and Tuscola Investments, LLC, for the property at 1000 East South line Road. Truitt seconded. VOTE YEA* Cleland, Henderson, Hoey, Maxey, Seip, Shoemaker, Slaughter, Truitt.

Other

Council will act on the FY 2014 tax levy at the next council meeting. Treasurer Long announced she still has not heard from the county about the expected EAV. Long reported we have been within five cents per \$100 of EAV for the last seven years.
