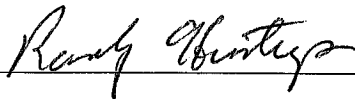

**Tourism Board Meeting

April 19, 2022**

The meeting was called to order at 8:30 am. In attendance: Drew Hoel, Bill Hill, Stacey Rae, Randy Hastings, Alta Long, and Anna Nelson.

Randy motioned for an approval of minutes from the February and March meetings and Bill seconded. All in favor motion passed.

Randy made a motion to approve the bills list from the 2/11/22-4/14/22 for \$2,248.27 and Stacey seconded. All in favor motion passed.

Old Business:

Anna shared the website updates with the board including a secondary navigation bar and event listing page. Alta mentioned they plan to continue updates to keep the website fresh and not get outdated. After the chamber directory page they plan to work on SEO.

Anna updated the board on fireworks. She explained that they now have 2 contracts to review- one from a new company and then other is the same crew under a new company. Brian met with the new company and they reviewed the launch sites. Alta said Brian would review the contracts and compare the amount of fireworks per company. Anna also mentioned that the Mo Do Fair will be conflicting with their fireworks date and most likely will not have many food vendors attend our event.

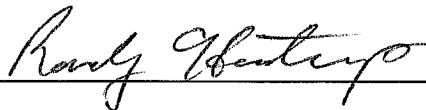
New Business:
