Contracts and Agreements

1. Mayor Kleiss opened discussion on the recent purchase of the quint fire truck and a change order request for add-ons. Chief Hettinger told council he was extremely impressed with the design, engineering, and craftsmanship on this truck. Many of the changes we requested are being done at no cost to the city. With the exception of the intercom and intake valves and fittings on the pump, the truck comes with many options, also at no additional cost. The add-on cost for the intercom system and valves and fittings is \$8,493, Hettinger stated. Truitt moved to approve the change order from American LaFrance in the amount of \$8,493, on the purchase of the quint

- fire truck. Henderson seconded. VOTE YEA* Cleland, Henderson, Hoey, Maxey, Seip, Shoemaker, Slaughter, Truitt. Chief Hettinger added the manufacturer would like him to come for a pre-delivery inspection.
- 2. Administrator Hoel discussed proposals for the replacement of the outfield fence at the south ball diamond. The committee looked at several options for fencing, Hoel stated, and recommend a vinyl-coated, chain-link with the bottom rail. Four proposals were submitted, with the low bid coming from Brooks Creek Cedar, Mattoon. Cleland moved to accept the low bid of \$21,500, from Brooks Creek Cedar for the south ball diamond fence replacement. Seip seconded. Hoel reported Chief Hastings has informed him Officer Heath Thurston became eligible for a step increase November 2012. Thurston would advance to Police Officer III. Hoey moved to approve the promotion of Officer Heath Thurston to Police Officer III, effective December 24, 2012. Henderson seconded. Administrator Hoel discussed a mower replacement for the park department. This purchase is in the capital plan for this year, Hoel stated. Tuscola Home Center has submitted a proposal for a zero-turn mower at a cost of \$14,923.39, less trade. Cleland moved to approve the purchase of a zero-turn Toro mower, with trade, at a cost of \$9,999. Shoemaker seconded. VOTE YEA* Cleland, Henderson, Hoey, Maxey, Seip, Shoemaker, Slaughter, Truitt.

Maxey moved council go into executive session to discuss pending or imminent litigation and possible land acquisition. Seip seconded. The time was 7:42 P.M. The meeting was called back to order at 8:39 P.M. with Cleland, Henderson, Hoey, Maxey, Seip, Shoemaker, Slaughter, Truitt and Mayor Kleiss present.
