- 7. Shoemaker moved to approve the 2023 water/sewer account write offs. Treasurer Long stated the write offs mean the accounts will not be pursued monthly. They will be kept in the accounting system. Should any of the former residents with delinquent accounts move back to town, they will have to pay their past due fees before getting service. - 8. The Tuscola School District has requested a portion of East Van Allen Street be closed for school construction from May 30 August 20. Rund moved to approve the request for the closure of a portion of East Van Allen. Hoey seconded. VOTE YEA* Brace, Hoey, Rund, Shoemaker, Slaughter, Waldrop.
