**AN ORDINANCE DECLARING A BUCKET TRUCK SURPLUS PROPERTY
AND AUTHORIZING SALE OF THE SAME**

PREAMBLE

WHEREAS, the City of Tuscola, Illinois (hereinafter the “City”) is a duly established and functioning home rule municipality in Douglas County, Illinois; and

WHEREAS, the City owns and possesses a certain 1993 Ford LN9000 with 75’ Telex Elevator Unit with Vehicle Identification Number 1FDZW90L9PVA31633, (hereinafter collectively the “Truck,”); and

WHEREAS, said Truck is no longer necessary or useful to the City or in the best interest of the City to retain ownership thereof; and

WHEREAS, the City does hereby desire to declare the Truck surplus property and to dispose of the same pursuant to ordinance authorizing the same.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TUSCOLA, DOUGLAS COUNTY, ILLINOIS, THAT:

Section 1. The aforementioned Truck is hereby declared surplus property.

Section 2. The City Administrator is hereby authorized and directed to sell the Truck at the best available price and by the most advantageous or convenient method, in his sole discretion, including but not limited to salvage or trade-in, and to execute any and all documents necessary for the conveyance of ownership of the Truck to the Buyer or Buyers.

Section 3. Severability. Should any part of this Ordinance be declared invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Ordinance.

Section 4. Effective Date. The City Clerk shall cause notice to be published in a newspaper of general circulation within the County that this Ordinance has been adopted and that copies are available upon request to the City Clerk. In addition, copies of the ordinance shall be posted in the City Hall and the Community Building. The publication shall be made within fifteen (15) days of the adoption of this Ordinance. The Ordinance shall be in full force and in effect twenty-five (25) days after said date of publication.

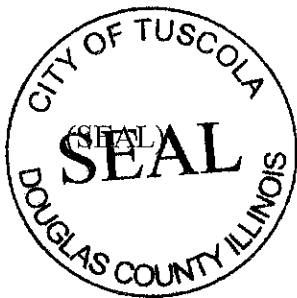
