The PSA is necessary to cover the increase in engineering costs for surveying of the water main extension. The extension will now loop from the Ensey Street residential project back into an existing line ½ block north on Center Street. The costs associated with the extension are to be paid by the City. Morris moved to approve the amendment to the PSA with Donohue and Associates for the Ensey Street water main extension in the amount of \$5000.00. Shoemaker seconded.
