AN ORDINANCE AUTHORIZING THE EXECUTION OF THE IMLRMA

MINIMUM/MAXIMUM CONTRIBUTION AGREEMENT

PREAMBLE

WHEREAS, the City of Tuscola, Douglas County, Illinois, (hereinafter the “City”) is a duly established and functioning home-rule municipal corporation; and

WHEREAS, the City Council of the City of Tuscola, a member in good standing of the Illinois Municipal League Risk Management Association (IMLRMA) and party to the IMLRMA Intergovernmental Cooperation Contract, has been fully apprised of the IMLRMA Minimum/Maximum Contribution Agreement which amends and supplements the IMLRMA Declarations pages dated 1/1/26 to 1/1/27 and all endorsements thereto; and

WHEREAS, the City Council of the City of Tuscola finds it to be in the best interest of the City to make its IMLRMA contribution in accordance with the IMLRMA Minimum/Maximum Contribution Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TUSCOLA, DOUGLAS COUNTY, ILLINOIS, AS FOLLOWS:

1. That the execution of the IMLRMA Minimum/Maximum Contribution Agreement for a one (1) year period beginning 1/1/26 and ending 1/1/27 is hereby authorized.
2. That the Mayor and the City Clerk are hereby granted authority to execute the IMLRMA Minimum/Maximum Contribution Agreement which amends and supplements the IMLRMA Declarations pages dated 1/1/26 to 1/1/27 and all endorsements thereto.
3. That this ordinance shall take effect immediately upon its passage and approval.
