Tourism Board Meeting February 21, 2017

The meeting was called to order approximately 8:30 am. In attendance: Drew Hoel, Allen Schwass, Morrie Mendenhall, Alta Long, and Anna Nelson.

Note: A quorum was not present, therefore the minutes and financial statements were tabled to next meeting.

Old Business:

Anna informed the board she will be submitting the annual report to council. If any board members have changes let her know before Friday.

Anna explained to the board that they made a few changes to the Christmas decoration. Originally they had planned to purchase a large 14ft tree for festival corner. After planning placement for the tree, they found it would be difficult to see from the road. After much discussion, they decided they would like to purchase additional snowflakes to finish out the corridor. They also have a couple ideas for next year, but would like to get the snowflakes ordered before the sales ends this month.

Alta updated the board on Sparks in the Park entertainment. She informed them that they have secured the Lumberjack Variety show for July 8th. The show can be broken up into smaller shows throughout the day or one large show before fireworks. She also explained she has been unsuccessful in securing a Christian artist because many of them are already booked. She does have one more lead after contacting the agent from last year. Zachary Williams currently has a number one song one the Christian charts for over 11 weeks. He would cost between \$5,000 - \$6,000 plus \$4,000 for the stage.

Alta asked for feedback if she should continue perusing a Christian artist, or if the Lumberjack show should be the main entertainment before the fireworks. The board agreed the Lumberjack show would be a great addition to the event, but would also like to see a concert at the park. Alta said she will work with the agent to see if they can come to an agreement on price and stage size.

Anna informed the board that the Miss Tuscola Pageant is March 25th. Donations letters have been sent out, and they are have received several donations so far.

New Business:

Alta presented the hotel/motel tax for 2016. She was pleased that the revenues continue to increase.

Alta presented the logo project. They have worked with a couple designers on new logos, but still haven't found anything that they like yet. She's hoping to get revisions on the last round of logos. Overall the logos had too much detail to be readable when small.
