Tourism Board Meeting July 15, 2014

The meeting was called the meeting to order approximately 8:30 am. In attendance: Donna Kidwell, Randy Hastings, Devon Flesor, Drew Hoel, Karen Dukeman, Alta Long and Anna Marx.

Motion to approve the minutes from the June 17, 2014 Board meeting made by Donna, seconded by Karen. All in favor, motion passed.

Motion to approve the bills list from 06/13/14 - 07/11/14, in the amount of \$14,661.66 made by Randy, seconded by Donna. All in favor, motion passed.

Old Business:

Anna and Alta gave the board a recap of the Sparks in the Park. Anna explained over all the day went very well, however the day did have a few issues. The biggest issue of the day was the parade starting backwards on the route. Alta explained this did create a lot of congestion inside the park for the lineup. The Army band, strongman, and magician were all very well received. Drew mentioned that overtime hours for additional City staff would be important for next year's festival. Anna reported that the fireworks donations totaled over \$4,000.00. A large contribution was made from Lyondell of \$1,000. Alta mentioned she had received many compliments on the fireworks. Discussion was also held on when to have next year's festival, on the 4th weekend or the weekend after. Alta explained there were pros and cons with each option and the main conflict with having it on the 4th competing with Champaign's fireworks. Several board members thought having the fireworks Friday before or the Sunday after. Some members thought it might be too late to do it the week after.

Anna gave an update for the Market on Main. Attendance is equivalent to last year's market. Only one resale vendor has signed up so far. Alta mentioned that at the end of the season we might need to reevaluate.

Alta informed the board that they all had been reappointed to the Tourism board. Randy was also reappointed as President.

New Business:

Anna informed the board on status of the chocolate bar promotion. Tanger recently asked for 50 more to be made. Although the promotion is successful at Tanger, the downtown stores are not seeing many, if any coupons returned. Vintage Karma and the Vault have not received any back. Donna said that Winterberry has received 2 over several months. Devon thought the Candy Kitchen had seen a few back. The board decided it might be best to phase out the candy bar promotion, as they don't have a long shelf life and they have a tendency to get eaten by staff members. Anna will continue to research other promotions to help with ad tracking and promote downtown businesses. Alta also asked if any coupons are returned to please return them to City Hall so that they can be tracked.

The 2013-2014 CVB grant has been complete. The group is now waiting for the reimbursement. Alta explained that typically takes place in late September.

2014-2015 CVB grant has been submitted and is awaiting approval. Alta explained we increased our ads this year to \$19,000, which includes a \$3,000 contribution for regional brand campaign. The marketing campaign for 2013-2014 is complete. Thus far the CVB has a logo, tagline, website and marketing plan for the next three years. In the upcoming grant photography, itineraries, social media, SEO, and ad placement in Illinois and Midwest travel guides. Devon mentioned she really like the idea of itineraries to help promote bus drop offs to downtown. She recommended Hardy's Reindeer Ranch to work with as they already have a Amish country tour.

Donna made a motion to adjourn, seconded by Randy. All in favor, meeting adjourned.
