Mayor Kleiss went over the items on the consent agenda:

One payment was to Earl Walker Company in the amount of \$55,404.23, for annual oil and chip. The other was \$25,500, for shaft end bearings at the sewer plant. Mayor Kleiss thanked Foreman Cruzan and the city crews for their work repairing the water leak at Carico and Barker, adding it proved to be quite a challenge. Treasurer Long reported Eddie Boutilier and Red Barn Veterinary Services are delinquent on their TIF loans.

City Administrator

Administrator Hoel reported the water tower was power washed last week and looks much better. The \$5000 cost was included in the water fund budget.

The leak detection analysis reported 16 leaks, mostly surface lines and hydrants. The crews are working to repair those now. There was one main leak, Hoel added. It will be worth the expense to repair.

Contracts and Agreements

Mayor Kleiss reported Josh and Paylee Ochs have sold their Tropical Sno business and are requesting a lease assignment to the new owner, Gina Romine, through August 19, 2018. Day moved to approve the lease assignment to Gina Romine for the Tropical Sno through August 19, 2018. Truitt seconded. VOTE YEA* Cleland, Day, Hoey, Rund, Shoemaker, Slaughter, Truitt, Waldrop.

Other

- Hoel announced the application period for the street department position has closed.
 The part-time police secretary position application is still open.
- The Special Use Permit discussion was tabled until a written report is received from the Plan Commission.
- Slaughter asked about the City Hall sign and what the next step would be. Mayor Kleiss
 answered he likes the pole and the arm pointing upwards. This would have to re-clad so
 it looks better. Administrator Hoel agreed with the Mayor, adding it stands out. Kleiss
 would like to have someone with some sign knowledge come and offer suggestions.
- Slaughter stated the downtown beautification is going great, but wants to know what can
 be done about the fence just south of City Hall. Administrator Hoel answered he has an
 estimate on his desk for replacing the fence. He thinks this will require tearing out the
 fence and posts and starting over.
