Requested Time on the Agenda

Brett Adkisson, local contractor, addressed council with some questions he has about the city's bid award process. Adkisson began by giving his background information and stated he has had great support from the city over the years. Adkisson then referenced a recent roofing bid that went to an out of town contractor. According to Adkisson, the city received two bids on this particular project — his and the awardee's. Adkisson's bid was \$100 higher than the out of town bidder. Adkisson felt that for only \$100 difference, the bid should have gone to him since he is local. Adkisson also stated he and the other contractor were not bidding 'apples to apples'. If they had both been bidding the same roof type, his (Adkisson's) bid would have been much lower. Adkisson then asked if council reviewed bids. Several members answered the bids are available for them to review but they rely on Administrator Hoel and Foreman Cruzan to go over the bids and make recommendations to council.
