Contracts and Agreements

• Mayor Kleiss reported one of the HVAC units at the library is in need of replacement and All Pro Heating, AC and Plumbing has submitted a proposal for installing the new system. Slaughter moved to approve the proposal from All Pro Heating, AC, and Plumbing LLC, in the amount of \$11,107.50, for installation of a new furnace and air conditioning unit at the library.

- Morris seconded. VOTE YEA* Brace, Day, Hoey, Morris, Rund, Shoemaker, Slaughter, Waldrop.
- Treasurer Long spoke to council about the city's health insurance renewal options. Our current carrier, Health Alliance, submitted a quote 18% higher for calendar year 2022. Long looked at other carriers in our area but was unable to find any competitive quotes. Long stated by increasing the deductible on the Health Alliance plan and increasing the health savings contributions we would be able to keep the premiums the same for 2022. Long went on to say the recommended increased in the health savings contribution will increase the city's overall cost by ~6%, which is less than renewing with the same plan we have for 2021. For most of the city employees who do not use insurance over the deductible amount, there would be no additional out of pocket costs and some would see less out of pocket costs. Employees who use health services in excess of the deductible amounts may see increased out of pocket costs of up to \$1500. Long ended by saying she believes this is the best we can do given the environment. Hoey moved to approve the Health Alliance HMO network high deductible health plan with HSA (embedded deductible) with RX plan for the city's 2022 health insurance. Brace seconded. VOTE YEA* Brace, Day, Hoey, Morris, Rund, Shoemaker, Slaughter, Waldrop.
